

LSVT GLOBAL announces the 2012 LSVT[®] BIG Training and Certification Workshop Series for physical and occupational therapists

The LSVT BIG Training and Certification Workshop is a two-day program designed to train physical and occupational therapists in an intensive whole body amplitude-based training protocol for individuals with Parkinson disease. The fundamental treatment principles and rationale, key treatment elements, efficacy data supporting treatment outcomes, details of treatment tasks, and practical delivery and marketing considerations are taught through lecture, demonstration, and case study presentations. Participants should wear loose fitting clothing that allows freedom of movement for participation in hands-on practice and interactive sessions. This training qualifies for 12 contact hours.

Steps for Certification:

- 1. Register for a two-day LSVT BIG Training and Certification Workshop.
- 2. Complete two required pre-workshop readings; participants are responsible for information in these readings. <u>These readings will</u> <u>be sent as email attachments with your workshop confirmation</u> (24-48 hours after registration is processed).
- 3. Read and accept the Clinician Confidentiality and Practice Agreement, attendance and cancellation policies.
- 4. Attend the entire two-day LSVT BIG Training and Certification Workshop
- 5. <u>Complete a Certification Exam with an 85% score required to</u> <u>receive certification</u>. The exam will be administered during the two-day training course. If a participant does not pass the examination, there will be an opportunity for a post-workshop learning task to complete the certification requirements.

Cynthia Fox, Ph.D., CCC-SLP

Cynthia Fox, Ph.D., CCC-SLP received her doctorate degree in Speech and Hearing Sciences from the University of Arizona, Tucson. She is an expert on rehabilitation and neuroplasticity and the role of exercise in the improvement of function consequent to neural injury and disease. Dr. Fox is a leader in administration of LSVT LOUD speech treatment for people with Parkinson disease (PD). She was the first to apply this treatment to other disorders, such as multiple sclerosis and pioneered the application to pediatric populations. Dr. Fox has worked closely on the development of a physical therapy program - LSVT BIG that was modeled after LSVT LOUD. Dr. Fox is a research associate at the National Center for Voice and Speech and Co-founder and Chief Clinical Officer of LSVT Global, Inc.

Patricia S. Brown, PT, DPT, NCS

Ms. Brown received her Bachelor of Science in Physical Therapy from California State University Long Beach and her Doctor of Physical Therapy from Western University in Pomona . LSVT BIG Certification Renewal

LSVT BIG Certification requires renewal once every 2 years. The process of LSVT BIG Certification renewal will be primarily web-based and involve the following steps:

- Complete an LSVT BIG continuing education activity (provided via web-based reading/video/exam)
- Document use of LSVT (survey questions related to number of patients treated and general treatment outcomes)
- Provide updated contact information for patient referrals
- Pay renewal fee
- LSVT BIG Certified clinicians will be contacted by LSVT Global when it is time for their certification renewal
